- All harnessing equipment and horses are supplied. Light & draft horse breeds are used.
- All horses are well-trained and gentle.
- Instruction is provided by professional horse driving expert, Delbert Jones, and his assistants.
- All instructors have at a minimum of ten years of experience in driving light to draft horse horses.
- All clinic participants are invited to attend an annual **Farm Days** event hosted by Delbert Jones the following weekend, March 13, 14, & 15. This event includes multitudes of enthusiasts driving and doing farm chores with their teams. You may participate at no extra cost.
